# **Terms & Conditions**

# Vantage Prime Affiliates Festival

- 1. This Festival ('Promotion') commences on 1 October, 2021 and ends on 31 December, 2021 ('Promotion Period').
- 2. To be eligible for this Promotion, during the Promotion Period you must meet both criteria below ("Eligible Affiliate"):
  - You have already had an Affiliate account with Vantage FX or become a Vantage FX Affiliate
  - Must opt in via the Promotion landing page on our Prime website

For the Promotion, Affiliate accounts include Vantage FX CPA, IB and Hybrid programs.

3. Prizes will be given to Eligible Affiliates in each of the 4 categories:
